Paper (treated with resin, chainlines and laidlines but no visible watermark), 215 x 145 mm, i + 120 + i ff., numbered i + 1-120 + ii. The endleaves, numbered i and ii, may once have formed an outer wrapper, and consist of parts of a notarial document; see below. The edges of the document serve as guards between Quires 1 and 2 and Quires 11 and 12. Single column, 34-39 lines to a page, frame-ruled in crayon. The early pages of the book much wormed.

1 endleaf (f. i) + 1-12¹⁰ (ff. 1-120) + 1 endleaf (f. ii).

Catchwords.

Written in a humanistic script, without colour. Gothic 'ribbon' initials at the beginning of orations. Headings in black capitals, the vowels deliberately arranged irregularly.

In five books, with space left for the completion of the rubric after the preamble of each. Book 1 begins on 48^r, Book 2 on 67^r, Book 3 on 78^r, Book 4 on 91^v, Book 5 on 104^v.

At the end of the text on 120^v is added

i and ii, perhaps the original covers of the book, contain on i^r and ii^v part of a 15th century notarial document about the sale of land by Florentius, resident of *insula Arben'*, i.e. Arba, Dalmatia (modern-day Rab, Croatia), under the procurator Andreas, signed ii^r by the vice-domini Teresius and Ricardus(?). Also on ii^r is the name *ser Adalghen' Tayacozo* (Tagliacozzo?). The edges of the same document protrude and serve as guards between 10^v and 11^r, 110^v and 111^r.

Upside down on i^r (presumably once the front cover), *Ciceronis orationes . Oratio Contra Catilinam ad senatum II, ad Populum II Oratio [pro Mar]cello / Sallustii in Ciceronem / Ciceronis ad Salustum / De Fato*, the letters deliberately (and decoratively) unevenly arranged and irregularly spaced.

Inside the modern covers are pastedowns from a 15th century edition of Thomas Aquinas, *Summa theologica Pars 1^a q. 85*. Inside front cover: end of 1^a q 85 a 2 ad 3 *de rebus exterioribus* ... and the beginning of a 3 ad 3 *Ad Tertium sic proceditur* ... ending *Uno modo absolute secundum quod in se est* 1^a q 85 q 7 a3 ad 3. Inside rear cover: 1^a q 85 a 5 co et *ratiocinando et ideo intellectus* ... ending *homo magis alio in[telligit]* 1^a q 85 a 7 arg 3.

Origin: written in Dalmatia on the island of Arba (the modern-day island of Rab, Croatia), and completed 26 May 1424, according to the scribal colophon on 47^v: *Peridmaton id est de fato Libelus explicit. Arbi scriptus 1424 . xxvi . Maii.*
